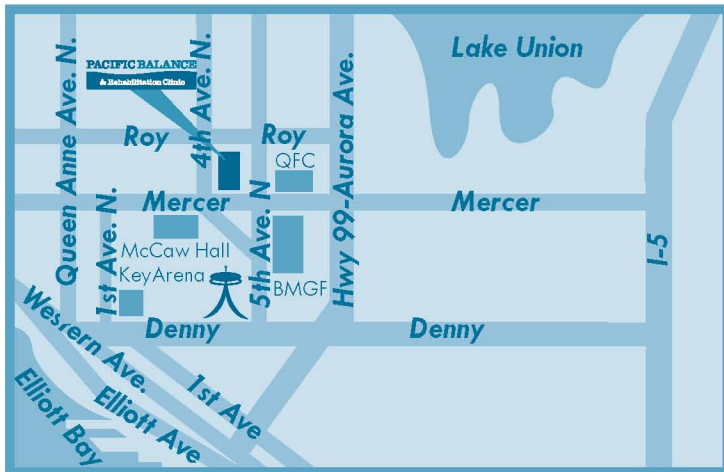

From I-99 southbound Turn right onto Roy Street, before Denny Way. Left on 4th Ave N. Left into "Public Parking" garage.

From I-99 northbound Take Western Ave ramp exit. Stay straight, going northward on Western Ave. Turn right onto Broad St. Left on 5th Ave N. Left on Roy St. Left on 4th Ave N. Left into "Public Parking" garage.
